

## Goals

The Northern and Southern New Jersey Chapters of the Association for Professionals in Infection Control and Epidemiology, Inc. and the New Jersey Department of Health and Senior Services believe that the practice of infection prevention requires the knowledge and understanding of many facets of this health field. This five-day course is designed to prepare the new practitioner or an individual responsible for infection prevention to perform the duties and responsibilities required by his/her position in an ambulatory, alternative, acute, or long-term care facility.

## Objectives

- Identify the modes of transmission, incubation periods, host resistance, and susceptibility to various infections and communicable diseases.
- Implement appropriate measures to prevent the spread of infection.
- Define the principles and processes used in sterilization, disinfection and sanitation in the health care facility.
- Present the management and communication skills necessary for the coordination of an effective infection prevention program.
- Define the governmental regulations and standards which govern infection control practice.
- Define criteria for identifying hospital associated infections in the acute or chronically ill patient.

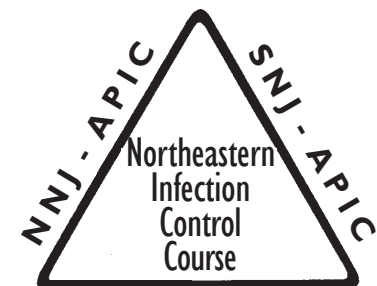
