Summary of Legislative Report – Betsy Marinella SJ APIC Past President/Legislative Representative	<p>My report will include information on any bills affecting Infection Control and Prevention that are presently in the US Congress and NJ Senate/Assembly.</p> <p>Additional information can be obtained by entering www.apic.org and clicking on Federal and State Legislation and then hitting Go where US Congress is located. Under each bill there is a link that will take you directly to the bill. Also, change US Congress to New Jersey and hit Go and this will, also, take you to the bills and again, link is available to obtain the bill.</p> <p>In regard to Assembly Bill A1860 introduced and proposed by Assembly Member Herb Conaway (D-7 Burlington and Camden), the bill would require general hospitals, comprehensive rehabilitation hospitals, and nursing homes to implement infection control practices that incorporate SHEA guidelines, in order to reduce the number of health care facility-</p>

	<p>acquired infections, especially infections due to antimicrobial-resistant organisms such as MRSA and VRE. At present the bill has been referred to the Committee on Health and Senior Services, which Assembly Member Conaway chairs.</p> <p>A letter was sent by Pat Lafaro (Northern NJ APIC Chapter Legislative Representative) to Simone Lawrence at NJHA requesting their assistance to defeat this bill. Concerns included the additional burden for data gathering responsibility that will be placed on Infection Control Professionals. From my standpoint as SJ APIC Legislative Representative and a Long Term Care (LTC) Infection Control Professional, I further expressed that compliance with the bill would not be possible in the LTC setting unless additional staffing, technology, and additional monies were made available.</p> <p>Jessica Cohen, Director, Legislation of NJHA is in receipt of the letter from Northern APIC. NJHA has already reached out to the sponsors and to the Department of Health in regard to the bill.</p> <p>At the meeting on Friday, 2/1/08, copies of the bill were given to Dr. Corey Robertson and Dr. Barbara Montana who will be discussing it with Dr. Eddy Bresnitz.</p>
